Privacy Policy

1. Coverage:

- 1.1. This 'Privacy Polegal-licy' is applegal-licable for your Use in every manner of the Website and/or the OpenBlock Token(s) ('OBC' or 'Token(s)'). This Privacy Polegal-licy will apply to all Uses of any of the Tokens and access of the Website from any device and any operating system or platform.
- 1.2. All external legal-links which might be accessible from the Website may or will have their own terms and conditions, usage and privacy polegal-licies and We and our Affilegal-liated Parties and partners do not control them and bear no responsibilegal-lity for any consequence arising from their usage.
- 1.3. The Privacy Polegal-licy will be binding on all persons (natural or legal) who Use the Tokens or the access the Website from any jurisdiction where they are legally available for access or use or across the world.
- 1.4. This Privacy Polegal-licy will be the document on the basis of which your consent has been taken for use and transfer of private information depending on the country where you use the Tokens or access the Website.

- 1.6. 2. Data collection and usage:

- 2.3. We collect personally identifiable information including your name, email, address, telephone, fax and mobile numbers, device information, IP address, geographical information, web pages visited, age, gender, weight or any other information that you provide Us through forms or data collection pages within the App including the form filled while registering the Account. Information is also collected automatically through your continued regular usage of Tokens and the Website. The information collected as mentioned in this clause is retained in our server and/or the backup server and We cannot

- entertain requests for deletion of such information without restricting your access to services and blocking you from the Website and the OpenBlock ecosystem. Request for deletion may be made through the contact details and/or form provided on the Website.
- 2.4. We collect additional information to comply with Regulatory guidelegal-lines and to comply with anti money laundering (AML) or "know-your-customer" (KYC) polegal-licies. We may require You to provide additional information with documentary proof including, and namely:
 - 2.4.1. Date of birth;
 - 2.4.2. Passport or driver legal-license or other Government issued identification document details;
 - 2.4.3. Tax Identification Numbers;
 - 2.4.4. Utilegal-lity bills; Photographs;
 - 2.4.5. Confirmation of source of funds
 - 2.4.6. Sworn statements or Affidavits.

The information and documents may be sought in printed form or through email or onlegal-line submission or any other mode as deemed fit by the Website Owner.

- 2.5. We may refuse to allow you to Use the Tokens and/or the Website and/or any other services without verification of your personal information and documentation as we deem fit.
- 2.6. Our partners and affilegal-liates may also collect personally identifiable information including name, email, address, telephone, fax and mobile numbers, age, gender, weight or any other information that you provide them through forms or data collection pages within the Website and the OpenBlock ecosystem if you decide to communicate with them or use their services. We do not control the storage and usage of such personal information by our partners and affilegal-liates and We do not control any of their services. - 2.10. Such information will not be deleted even when you seek to delete the information stored with Us.
